B. Payment Agreement

The parties to this agreement are Pet Vet Animal Clinic & Mobile Practice, Ltd., an Illinois corporation ("Pet Vet"), and First Owner, \_\_\_\_\_, and Second Owner, \_\_\_\_\_, (collectively, "Owner")

In consideration of their mutual promises to each other, the parties agree as follows:

1.00 From time to time Pet Vet will perform veterinary services on animals owned and as requested by Owner. Such services include examination, diagnostic, therapeutic, medical, surgical, vaccination, and euthanasia procedures. These procedures shall be performed on the animals named and described in Section A, Owner and Designated Animal Information, of this instrument ("Section A"), and on any other animal for which Owner designates from time to time in an addendum ("Addendum"), a true and correct copy of which is attached hereto. Any animal, whether designated in Section A or in an Addendum is referred to as a "Designated Animal".

2.00 Owner shall pay any and all charges for services rendered by Pet Vet in full, and no later than five (5) days after the date of the invoice. The date of the invoice shall be no later than the first day of the month next following the date that services are completed ("the billing date").

3.00 **ANYTHING TO THE CONTRARY, PET VET MAY PERMIT OWNER TO RETAIN A BALANCE DUE. HOWEVER, SUCH BALANCE SHALL INCUR FINANCE CHARGES AS FOLLOWS: THE HIGHER, PER MONTH, OF (i) \$5.00, or (ii) 1.5% (18% PER ANNUM SIMPLE INTEREST) OF THE BALANCE DUE ON OWNER'S ACCOUNT IF IT HAS NOT BEEN PAID IN FULL AS OF THE FIRST DAY OF THE MONTH NEXT FOLLOWING THE BILLING DATE. THE FINANCE CHARGE SHALL ACCRUE AS OF THE BILLING DATE.**

4.00 Pet Vet does not waive, and reserves the right at any time, to terminate the payment provisions of paragraph 3 above and proceed with collection procedures. Collection procedures include (i) collection agency actions outside of court (for which collection agency fees and costs advanced will be charged), and (ii) suing Owner in a court of competent jurisdiction ("litigation").

5.00 Owner acknowledges that it is its responsibility to file any Addendum with Pet Vet. Owner hereby authorizes Pet Vet to provide services to an animal as if an Addendum covering that animal were on file. Such animal becomes and is a Designated Animal.

6.00 This agreement shall remain in force until otherwise terminated by Pet Vet or Owner in writing to Owner or Pet Vet, as the case may be, at their respective addresses. At that time no further services will be performed by Pet Vet, and any existing balance shall continue to be subject to the terms set forth in Paragraphs 2.00 and 3.00.

7.00 If this agreement is signed by less than all of Owner, the signing Owner ("Signing Owner") hereby warrants and represents, and acknowledges that Pet Vet relies thereon that:

(i) Signing Owner has full power and is authorized by non signing Owner ("Non Signing Owner") to execute this agreement in Non Signing Owner's behalf and to bind Non Signing Owner hereto;

(ii) Signing Owner hereby guarantees absolute and unconditional payment and performance of all of Owner's liability hereunder, which liability is joint and several; and that

(iii) Signing Owner shall indemnify, become responsible for and forever save Pet Vet harmless from any and all judgments, damages, decrees, costs and expenses, including reasonable attorney fees, which Pet Vet may legally suffer or incur, or which may be legally obtained against Pet Vet, for or by any reason of negligent services performed by Pet Vet as to any Designated Animal.

8.00 The aforesaid Owner and Animal Information set forth in Section A above, entitled "Owner and Designated Animal Information", is incorporated into and made a part of this agreement.

9.00 In the event of litigation between the parties, jurisdiction and venue shall lie in the Circuit Court of the 22<sup>nd</sup> Judicial Circuit, McHenry County, Illinois, and the suit shall be subject to the substantive and procedural laws of the State of Illinois, without regard to the conflict of laws requirements thereof. In the event Pet Vet prevails in the litigation, any judgment shall also include Pet Vet's collection agency, court, service of process, discovery and reasonable attorney's fees and costs.

10.00 For all purposes herein, where the context requires:

10.01 The terms "including", "includes", or "included" mean "including but not limited to", "include/s but (is/are) not limited to", or "included, but not limited to", as the case may be;

10.02 Reference to either party includes that party's employees, officers, agents and assigns;

10.03 Use of the singular includes the plural;

10.04 Use of the neuter includes the masculine or feminine, as the case may be;

10.05 All obligations and liabilities of Owner are joint and several.

11.00 Owner represents and acknowledges that Pet Vet relies thereon as follows:

11.01 Any provision in this agreement found to be invalid by a court of competent jurisdiction shall not invalidate any and all other provisions hereof.

11.02 The information provided in Section A, any Addendum thereto and any other relevant information in this agreement is true and correct.

11.03 Owner has read and understands the provisions of this agreement and agrees to be bound thereby.
